

# Alabama National Fair Online Privacy & Payment Security Policy

Your privacy is important to Alabama National Fair. This privacy statement provides information about the personal information that Alabama National Fair collects, and the ways in which Alabama National Fair uses that personal information.

## Personal Information Collection

Alabama National Fair may collect and use the following kinds of personal information:

- Information about your use of this website including pages visited and purchases;

Alabama National Fair will take reasonable technical and organizational precautions to prevent the loss, misuse, or alteration of your personal and payment information. Alabama National Fair will store all the personal information you provide on its secure servers.

Information relating to electronic transactions entered into via this website will be protected using the same e-mail security utilized by Alabama National Fair in its daily business. **Financial information is collected by a reputable and secure Credit Card processing company and is not entered or stored on Alabama National Fair servers.**

## **Alabama National Fair Refund Policy**

Alabama National Fair refund policy includes the following obligations and restrictions:

1. No refunds are made; however, in the discretion of Fair Management a refund will be considered if extenuating circumstances warrant an exception to this policy.
2. All requests for refunds must be made in writing within 15 days of the initial request to the Fair Management for a refund.
3. Any refund requests made will be considered on a case by case basis and will be granted in the sole discretion of Fair management and will be determined within 60 days of the conclusion of the Alabama National Fair.
